### Bar Service Policies and Procedures

**Cash Bar** - Individual guests pay for their own beverages via credit card or smart pay only. Price is inclusive of service charge. Subject to 8% sales tax.

**Hosted Bar** - Client/Host pays for all beverages consumed. Beverages will be billed based on consumption. Hosted bars subject to 22% service charge and 8% sales tax.

### **Unlimited Hosted Packages, Per Person**

- Client/Host pays a per person charge for an unlimited hosted bar based on final guest count.
- Packages subject to 22% service charge and 8% sales tax.
- Service charge does not include bartender gratuity.

#### Labor

Host pays for all bartenders and support staff labor whether a Cash or Hosted Bar. Uniformed, bartending labor, who have received state approved training for alcohol service (such as ABT) will be billed at \$42.00/ staff person per hour with a four-hour minimum. The ratio of one bartender per 75 guests applies and a minimum of (1) one bar manager per event. Backbar/support staff may be requested/required. Additional staff may be required to accommodate specialty cocktail service (i.e. champagne toast, passed drinks, or dinner wine service). The selected catering company may pass/ serve but Asterisk's appointed beverage staff are required to prepare the beverage to be passed. \*Labor fees do not apply to beverage minimums.

- A minimum of (30) days prior to the event date, the client is required to secure the preliminary Beverage Event Order (BEO) and pay the initial deposit, confirming all beverage products. Within two weeks of the event, but no less than (7) days prior, only the guest count may be changed to increase numbers. Not complying with this policy may result in a dry event, as products may not be available.
- A soft last call will be 45 minutes before end of event. Last drink will be served 30 minutes before
  end of event.
- Asterisk has a no shot policy.
- · Per Colorado liquor license requirements, food service must accompany alcoholic beverage service.
- Specialty orders can be accommodated if ordered no less than 30 days prior to event. Client is responsible for full purchase of special-order items. Any items not consumed remains the property of Asterisk.
- Colorado state law prohibits the sale to and consumption of alcoholic beverages by anyone under 21 years of age. All guests will be carded and no service will be given to those that do not have a valid government issued identification card.
- Any overly intoxicated or underage guest will not be served at the discretion of the bartender and supported by Asterisk management. If a situation is escalated, the guest may be asked to leave, and bar service may cease. Bartender reserves the right to refuse service to any guests that appear to be intoxicated
- No alcoholic beverage can be brought onto the premises; products brought on to premise will be confiscated and may result in closure of bars and fees assessed.
- Service charge does not include gratuity. Suggested bartender gratuity of \$25.00/service hour per staff person.
